

# Membership Application Form for International Associate Members Standard Swappable Battery Consortium for Small E- Mobility

#### Membership Types

- 1) Founding Member: Refers to entities that initiated the establishment, bearing joint responsibility for the main research and development activities of the consortium to fulfill its mission. They serve as the executive committee for the first three years to set the direction, policies, and operational plans of the consortium and appoint working groups as appropriate.
- 2) Honorary Regular Member: Refers to legal entities involved in the establishment of the consortium and conducting activities aligned with the consortium's goals and mission, participating in activities to promote the consortium's goals and mission, and approved by the executive committee.
- 3) Regular Member: Refers to legal entities conducting activities aligned with the consortium's goals and mission, participating in activities to promote the consortium's goals and mission, expressing interest in joining the consortium, and approved by the executive committee.
- 4) Associate Member: Refers to Thai legal entities interested in businesses or technologies related to the value chain of standard swappable batteries for small E-Mobility, expressing interest in joining the consortium, and approved by the executive committee.
- 5) International Associate Member: Refers to foreign legal entities interested in businesses or technologies related to the value chain of standard swappable batteries for small E-Mobility, expressing interest in joining the consortium, and approved by the executive committee.
- 6) **Honorary Member**: Refers to:
  - a) Distinguished individuals involved in the establishment of the consortium, invited by the executive committee's resolution.
  - b) Representatives of advisory agencies involved in the establishment of the consortium, invited by the executive committee's resolution.



#### Member Benefits

## 1) Founding Members

- d. Have the right to receive news and participate in activities organized by the consortium.

- a. Have the right to access information and proposals generated by the consortium.
- b. Have the right to receive news and participate in activities organized by the consortium.

#### Termination of Membership

Membership will terminate due to any of the following reasons:

- 1) The legal entity status ends, or the individual dies.
- 2) Resignation by submitting a notice to the executive committee at least 60 days in advance.
- 3) The executive committee officially resolves to terminate the membership status.
- 4) Failure to pay the consortium's maintenance fee within 180 days after the invoice date.

**Note:** For those applying for membership with this application form, membership will terminate under the following conditions:

- Membership will end on December 31, 2025.
- Membership renewal can be done by paying the consortium's maintenance fee for that year. The consortium will send an invoice in December 2025. <u>Failure to pay the</u> <u>maintenance fee within 180 days after the invoice date will result in termination</u> <u>of membership</u>.
